Cross Country - 2'7" @ 300 mpm

Stadium - 2'7"

NOVICE: Dressage - USEF 2006 Novice Test B

Cross Country - 2'11" @ 350 mpm

Stadium - 2'11"

GREEN STARTER: Dressage - 2007 USDF Intro Test A, Stadium - 18" max., not timed

STARTER: Dressage - 2007 USDF Intro Test B, Stadium - 2', not timed

BEG. NOVICE: Dressage - USEF 2006 Beg. Novice Test B, Stadium - 2'7"

NOVICE: Dressage - USEF 2006 Novice Test B, Stadium - 2'11"

TRAINING: Dressage - USEF 2006 Training Test B, Stadium - 3'3"

* Refunds: before closing date - less \$25 office fee, after closing date - none.

* Awards: Trophy and Ribbons to 10th place, each division

* All dressage in small arenas.

* Concessions available on Grounds.

* Classes may be divided or canceled as entries warrant.

* Medical armbands required for jumping. Please see Show Secretary if you do not have one.
