STARTER: Dressage – 2007 USDF Intro Test B  
Cross Country - 2'3" jumps, not timed  
Stadium - 2'3", not timed

BEG. NOV: Dressage - USEF 2006 Beg. Novice Test B  
Cross Country - 2'7" @ 300 mpm  
Stadium - 2'7"

NOVICE: Dressage - USEF 2006 Novice Test B  
Cross Country - 2'11" @ 350 mpm  
Stadium - 2'11"

#### COMBINED TEST DIVISIONS:

GREEN STARTER: Dressage - 2007 USDF Intro Test A, Stadium - 2' max (cross rails), not timed

STARTER: Dressage - 2007 USDF Intro Test B, Stadium - 2'3", not timed

BEG. NOVICE: Dressage - USEF 2006 Beg. Novice Test B, Stadium - 2'7"

NOVICE: Dressage - USEF 2006 Novice Test B, Stadium - 2'11"

TRAINING: Dressage - USEF 2006 Training Test B, Stadium - 3'3"

PRELIMINARY: Dressage - USEF 2006 Preliminary Test B, Stadium - 3'7"

#### GENERAL INFORMATION

\* Entry Fees: **Mini-Trial** - \$100.00 per division,

**Combined Test** - \$75.00 per division/ \$100 for two, same horse/rider combination

\* No cross entries between Combined Tests and the Mini-Trial, please.

\* Stabling: \$25.00 per night. On grounds, but **very limited**. Preference to out-of-town riders.

**\$25.00 Stall Cleaning Deposit will be collected when you pick up your packet.** Stalls must be stripped - Deposit will be returned when stall is stripped. **Straw bedding only, please.**

\* Refunds: before closing date - less \$25 office fee, after closing date - none.

\* Awards: Trophy and Ribbons to 8<sup>th</sup> place, each division

\* All dressage in small arenas. All on sand.

\* Concessions available on Grounds.

\* Classes may be divided or canceled as entries warrant.

\* Medical armbands required for all jumping phases & all jumping warm-ups.

\* Headgear and attire per USEF regulations. Show attire is still permitted, but per the USEF Rule EV113.8 Long or short-sleeved shirts with collar and without neckwear, of a conservative color, neatly tucked into breeches are now allowed for a one-day.

\* Competitors should have a valid 12 month health certificate on hand. KY State Officials may check them.

\* Please enclose copy of negative Coggins test dated within 12 months of June 7<sup>th</sup>.
